OUR VISION

Atlas Learning Academy strives to create a learning environment that encourages students to be confident individuals by offering developmentally appropriate instruction, diverse teaching styles, more one-on-one teacher/student time, and encouraging students to work beyond their potential.

Our modest school size allows us to develop close connections with our Atlas families. We provide a safe, nurturing and supportive environment, which allows students to feel free to express their individual ideas and personalities.

OUR MISSION

Our mission is to provide a learning environment that builds on each student's strengths. We encourage students to become independent and confident learners, and provide quality educational opportunities to ensure students reach their highest potential.

A Profile of the School Authority

Atlas Learning Academy has been an established elementary school since 2008 and continues to thrive in the community of Airdrie. We offer elementary programming for kindergarten to grade 6. While the majority of our students reside in Airdrie, we have many students enrolled from the surrounding areas, including Calgary.

We offer class sizes with a maximum of 16 students, which allows for more enriched learning opportunities and gives students the opportunity to develop their strengths and become confident learners. Our curriculum is aligned with the Alberta Programs of Study, with additional courses including Digital Literacy.

Our small class sizes allow us to explore and apply a variety of teaching and learning strategies that cannot typically be achieved in larger classroom settings. This permits the teacher to spend more time on required subject areas as needed by students and to develop academically appropriate individualized learning opportunities for all students who may require it.

Achievement Evaluation

Achievement evaluation is based upon a comparison of Current Year data to a set of standards which remain consistent over time. Our maintained overall results in the teacher category are reflective of the continued focus we place at Atlas Learning Academy on citizenship, community involvement, and accountability for our students.

1. Atlas students regularly contribute to their school community by being responsible Reading Buddies with other students, building leadership skills, and providing peer learning, and participate in monthly assemblies together and encourage each other for their contributions to the school as a whole.
2. Examples of the way Atlas students are contributing members of the greater community include participation in neighbourhood cleanups, displaying random acts of kindness on World Kindness Day, performing for local seniors' residents twice a year, visiting veterans and learning their story, and exhibiting responsible behaviours for others to follow at the local public library.
3. Weekly spelling tests and daily home reading programming encourage students from a young age to set aside time for practice. This helps to develop time management skills, which will assist students as they grow older and experience an increase in homework and studying expectations.

Although we have monthly newsletters, weekly emails, and continued communication representing the many ways students are involved in supporting our Atlas and local communities, unfortunately, there was a decline in the parent category. Below are the ways we have and will continue to address this concern:

1. The school has requested more parent volunteers for a variety of school activities, such as our Fall Family Night, curling days, weekly fun lunch program, and school dances.
2. In response to parent feedback to our annual internal survey, we have moved back to in-person parent-teacher interviews for the reporting period.

We feel that increasing the chances for parents to see first-hand the opportunities Atlas students have to build citizenship, participate in community activities, and be held accountable for lifelong learning will help inform their opinions.

Atlas maintained a measure of overall Excellence in the area of Programs of Studies and this can be attributed to the following strategies implemented at our school:

1. Atlas has an enthusiastic and motivated physical education and music teacher who provides engaging and memorable experiences for all students. Their continued exploration of professional development to improve and refine their skills is evident in our leadership knowledge and school concert productions.
2. Continuous focus on allowing dedicated time for teachers to collaborate and learn from each other in monthly divisional meetings.
3. Parent council continues to support the purchase of resources, including gym, music, and outdoor equipment, to push programming to the next level.
4. The opportunity for teachers to lead and students to participate in weekly clubs, including coding, crocheting, book club, and drama club. These options provide both teachers and students the opportunities to express their personal interests and learn through collaboration and exploration.

While we have maintained an overall acceptable measure, the parent category is at a concerning level. For the last several years, we have placed an importance on Renfrew Educational Services to provide support and build capacity within the classroom. This level of support will continue to directly benefit student and teacher growth.

Atlas Learning Academy will again utilize the Classroom Complexity Grant to support at-risk students by providing Educational Assistants to work one-on-one and/or in small target groups to further achieve academic goals.

We continue to encourage parents to advocate for their child's learning and approach administration with any concerns throughout the school year. Communication from the school to parents occurs regularly regarding at-risk students, and our focus will be on providing further clarity of the areas of concern and encouraging parent participation in student learning, whether it is at school or at home.

There has been a decline in this area of measurement in the parent category. We attribute this decline due to the lack of participation. We have continued strong results in both the teacher and student category over the last three years and have indicated overall satisfaction with the programming we offer at Atlas Learning Academy.

Priority 5: Teaching and Learning - Growing Community Within

To develop a sense of community from within, we will celebrate the arts, integrate nature into our daily practice, and highlight the individual successes of our students. Below is a list of strategies that we have implemented within the school and ones that we plan to apply in the upcoming school year:

- Recycling program within each classroom has been developed to promote the importance of working together to make our world a better place.
- Community garden will be implemented to encourage a sense of responsibility for students and to provide shared growth experience among the entire school.
- Increased volunteer opportunities such as the back-to-school open house, Fall family Night, Valentine's Day Dance, Bake Sale events, end of year Carnival Day, skating and curling opportunities during physical education class, invitation for parents to attend the school Science Fair and annual Cultural Day events. Additionally, parents have the opportunity to now have in-person parent teacher meetings in September, further providing chances for parents to observe what is happening within the school. This year, the Parent Council created a volunteer coordinator role, hosted in-person meetings, and will have a volunteer table at our annual Celebration of Learning event.

Priority 2: Learning Supports - Supporting Students Within our School

Our maintained results on this measure can be attributed to the following strategies:

1. Renfrew Educational Services provides Expanding Learner Supports, a grant with AISCA to provide small group and class wide support in Occupational Therapy, Speech Therapy and Psychology.
 - a. Speech therapists provide classroom and small group sessions twice monthly
 - b. Occupational therapists provide classroom and small group sessions twice monthly
 - c. Psychologists provide up to 3 psychoeducational assessments per year
2. School administration and Renfrew Educational Services have updated families on our continued partnership.
3. Atlas Learning Academy's IPP process continues to include regularly scheduled meetings including the homeroom teacher, principal, parents and IPP coordinator 3 times per year.
 - a. IPPs highlight coordinated supports in place for student learning needs.
